## **JUROR.....Eric Swangstu**

"Eric Swangstu is the founding director of The Art Mine Gallery, a gallery of contemporary art located in Port Hadlock, WA. He has exhibited his paintings and drawings in the Museum of Contemporary Art in Los Angeles, The Contemporary Museum in Baltimore, Exit Art in NYC, DC Art Center in Washington DC and The Port Angeles Fine Arts Center, among others.

He was involved in the first project to incorporate the arts and prime-time TV. Working with other artists they contracted with Spelling Entertainment to provide props such as museum pictures and art posters for the TV series "Melrose Place" which were later sold at auction by Sotheby's.

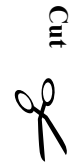
Eric also works closely with teenagers to forge their career paths in the visual arts. He has served as an admissions recruiter and faculty member of the Pratt Institute in NYC, The School of the Museum of Fine Arts in Boston and the Kansas City Art Institute and continues to work with students on the Olympic Peninsula to help prepare them for art school.

# 2008 JURIED SHOW ENTRY FORM

### CATEGORIES

- A. Two-Dimensional Art such as but not limited to oil, acrylic, water media, mixed media, original prints, collage, pastel, photography and drawing.
- B. Three-dimensional art such as but not limited to sculpture (any medium), basketry, ceramics, glass, jewelry & textiles.

### ENTRY FEE

- Each artist may submit five entries. Cost: for Sequim Arts members \$15 for the first entry, & \$5 for each additional entry. Non Members: \$20 for the first entry & \$5 for each additional entry.
- Entry fee nonrefundable. Check or money order payable to Sequim Arts.

### AWARDS

Over \$1500 in cash and prizes will be awarded.

### ELIGIBILITY & RULES:

- Open to all adult artists. All work must be original in interpretation and composition, not copied from copy-righted or published art or executed in a supervised class.
- Two-dimensional work must be dry, properly framed and wired for hanging with screw eyes and wire (no saw tooth hangers).
- All entries must have been executed within the last two years and not previously accepted into a Sequim Arts Juried Show.
- Two-dimensional work may not exceed 44 inches in the longest dimension including the frame.
- Three-dimensional work that requires special handling will be accepted at the discre-

tion of Sequim Arts.

- All artwork must be for sale and priced with the intent to sell. A 25% commission will be charged on all sales.
- If entry is judged not to be the same quality as the digital image or deemed inappropriate, Sequim Arts reserves the right to exclude it from the show.

### NOTIFICATION

Notification of accepted work will be mailed on April 7. Acceptance letters will include instructions for both hand and shipped delivery of work.

### ENTRY INFORMATION

Entries may be submitted by mail or email. Email entries should include all information requested on the entry form and followed up with a hard copy of the entry form and entry payment by March 23. Digital image files must be submitted on in a JPG format only. Mailed entries should be on a CD. Digital image files must be submitted on PC platform CD in a JPG format only. No files larger than 5MB please. Multiple images may be saved to one CD. Save each image as "title of work.jpg Write the entry title(s) and your name directly on the front of the CD with a permanent felt tip pen. (eg: EntryA My Home In Callam Bay.jpg)
